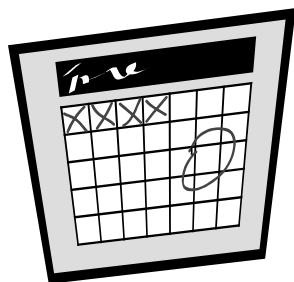

This course is intended for Sterile Processing Managers and Supervisors (new or experienced), Infection Preventionists, Materials Managers, Perioperative Managers and allied health personnel who perform and/or supervise cleaning, disinfection and/or sterilization services. The course covers basic management concepts as well as all regulations and recommended standards of practice for cleaning, disinfection, packaging and sterilization. All registrants will be provided with detailed handout materials and reference forms for use in managing their departments. Today, it is difficult to keep up with all the numerous changes in regulations and standards. **This 4-day course provides all the information needed to update you and ensure patient safety of reprocessed devices. Both hotels have agreed to extend the special room rates to accommodate travel plans for attendees.**

COURSE REGISTRATION DEADLINES: The deadline for the **PORTLAND, MAINE Course:** Early-bird registration fee of \$800 must be received by May 17, 2019. Regular registration fee of \$875 must be received by May 31, 2019. **PITTSBURGH, PA Course:** Early-bird registration fee of \$800 must be received by August 26, 2019. Regular registration fee of \$875 must be received by September 6, 2019. **YOU WILL RECEIVE A CONFIRMATION WITH DETAILED INFORMATION ABOUT YOUR HOTEL AND TRANSFERS TO AND FROM THE RESPECTIVE AIRPORTS.**

HOTEL INFORMATION: You must make your own reservations at the respective hotel for the course you wish to attend. All rooms are available from the Sunday night before the courses through the Wednesday night of the week (unless otherwise noted). If you cancel your course registration, you are responsible to also cancel your hotel reservation. Please note the hotel registration deadline dates. Embassy Suites Hotel, 1050 Westbrook Street, Portland, Maine. Deadline for hotel reservations is May 10, 2019. Reservations made after this date are not guaranteed for the special room rate of \$145 per night plus taxes. The hotel is in close proximity to Portland Airport. There is a FREE shuttle to and from the airport. Upon arrival at Portland, Maine airport, go to Baggage claim and look for the hotel kiosk. Pick up the phone for the Embassy Suites to arrange for pick-up. Hotel room rate includes free, full, hot breakfast daily and a manager's reception each evening for guests staying at the hotel. Check in time is 3:00 PM and checkout time is noon. There is a \$50 early departure fee if you check out prior to your scheduled check-out date. CANCELLATION is 72 hours prior to arrival. To make a reservation, call the hotel directly at: 1-207-775-2200 and mention "Sterile Processing Management Course group". Fly into Portland, MAINE Airport. Self-parking is free. Hotel has free WIFI and complimentary hotel shuttle (scheduled service) to and from downtown "Old Port".

Homewood Suites Hotel, 1410 Smallman Street, Pittsburgh, Pennsylvania. Deadline for hotel reservations is August 4, 2019. Reservations made after this date are not guaranteed for the special room rate of \$144 per night plus taxes. The hotel is in the downtown area

close to many attractions. The hotel also has a free shuttle service to transport you within 2 miles of the hotel – subject to availability. Transportation to and from Pittsburgh International Airport is available through Super Shuttle. You should make your reservations on their website: www.supershuttle.com – they charge an additional \$3 fee to book over the telephone. Upon arrival in Pittsburgh, go to Baggage claim and look for the Super Shuttle kiosk in the center of the area near the car rental booths. Hotel room rate includes free, full, hot breakfast daily and a manager's reception each evening **for guests staying at the hotel.** Check in time is 3:00 PM and checkout time is noon. To make a reservation, call the hotel directly at: 1-412-232-0200 and mention "Sterile Processing University group" in order to get the special room rate. The rates and room availability are not guaranteed after the deadline date. **Room Availability is limited due to football season.**
